



Daryeelka Canugga/Dugsiga barbaarinta kahor/Head Start wuxuu u baahanyahay Tallaalada Sanad Dugsiyeedka 2019-20

Waalidiinta iyo masuuliyiinta qaaliga ah ee ardayda ku jirto daryeelka carruurta Colorado, dugsiga barbaarinta kahor iyo barnaamijyada Head Start:

- Sharciga Colorado wuxuu u baahanyahay in ardayda ka qeybqaadato dugsiga daryeelka carruurta shatiga haysta, dugsiga barbaarinta kahor ama barnaamijka Head Start si looga tallaalo cudurada badan oo laga horti karo ka hortaga. Ardaygaaga waa in laga tallaalaa ka hortaga:
 - gowracadata, teetanada & xiiqdheerta (DTaP, DTP)
 - dabeysaha (IPV)
 - jadeecada, qaamow qanshiirka , jadeecada rubella (MMR)
 - cagaarshowga B (HepB)
 - jeermiska hargabka nooca b (Hib)
 - tallaalka bakteeriyaaalka (PCV)
 - busbuska (busbus)
- Tallaalada waxaa loogu taliyay fayruska shubanka, cagaarshowga A iyo hargabka, laakiin looma baahno.
- Lambarka, jadwalka iyo kala fageynta koorayaasha tallaalka loo baahanyahay waxaa lagu dajiyay Xarumaha Xakameynta Cudurada iyo Ka hortaga Guddiga Ka hortaga ee Dhaqanka Tallaalka (ACIP). Waxaad ka eegi kartaa nooca waalidka ku habboon ee jadwalka tallaalka haddeer ee ACIP ee carruurta 0 - 6 sano [jirka www.cdc.gov/vaccines/parents/downloads/parent-ver-sch-0-6yrs.pdf](http://www.cdc.gov/vaccines/parents/downloads/parent-ver-sch-0-6yrs.pdf).
- Fadlan u qaado diiwaanka tallaalka canugaaga oo la cusbooneysiisay dugsiga marwalba isaga ama iyada helayaan tallaalka.
- Haddii ardaygaaga uusan heli karin tallaalada sababaha caafimaadka, waa inaad xareysaa *Foomka Ka dhaafida Caafimaadka Tallaalka* oo rasmi ah dugsigaaga, oo saxiixay bixiyaha daryeelka caafimaad oo shatiga haysta si uu kuu siiyo tallaalada. Waxaad u baahanaysaa inaad soo gudbiso foomkan oo kaliya halmar, iyada oo macluumaadka ardaygaaga ama dugsigiisu isbaddalo moojee. Waxaad ka heli kartaa foomka www.colorado.gov/vaccineexemption.
- Haddii aadan dooranin in canuggaaga la siiyo tallaalka sida waafaqsan jadwalka hadda ee ACIP ee sababaha waxa qofku aaminsan yahay ama diimaha, waa inaad u soo gudbisaa dugsigaaga waxyaabaha caafimaadka aan ahayn ee lagaa dhaafay. Sii deynta aan caafimaadka aheyn waa in la soo gudbiyaa da' da 2 bilood, 4 bilood, 6 bilood, 12 bilood iyo 18 bilood. Ikhtiyaaro badan ayaa diyaar kuugu ah halkan www.colorado.gov/vaccineexemption.
- Qaar ka mid ah waalidiinta, gaar ahaan kuwa la jiro ardayda leh difaaca liita ee jirka , waxay rabi karaan inay ogaadaan daryeelada canuga, dugsiyada barbaarinta kahor iyo barnaamijka Head Start ee leh tirada ugu sareysa ee carruurta tallaalan. Dugsiyada waa inay u sheegaan macluumaadka tirooyinka tallaalka iyo ka dhaafidda tallaalka (laakiin ma ahan magacyada ama taariiqda dhalashada ardayga) waaxda caafimaadka gobolka ugu dambayn Diseembar 1 sanad walba. Heerarka tallaalka iyo ka dhaafidda tallaalka waxaa laga heli karaa www.colorado.gov/pacific/cdphe/school-and-child-care-immunization-data.
- Waxaad rabi kartaa inaad la hadashid bixiyaha daryeelka caafimaadka oo shati u haysta in uu bixiyo tallaalada ama hay'adda caafimaadka bulshada deegaanka (LPHA) wax ku saabsan tallaalada ardaygaaga u baahanyahay ama haddii aad su'aalo qabtid. Dear Colorado health care provider:

Colorado School Entry Immunization Law (25-4-901 et seq, C.R.S) and Colorado Board of Health rule (6 CCR 1009-2) requires students who attend a public, private or parochial K - 12 school, licensed child care, preschool or Head Start program to be vaccinated against many of the diseases vaccines can prevent. Students must be vaccinated against:

- diphtheria, tetanus and pertussis (DTaP, DTP, Tdap)
- polio (IPV)
- measles, mumps, rubella (MMR)
- hepatitis B (HepB)
- haemophilus influenzae type b (Hib)
- pneumococcal (PCV13)
- varicella (chickenpox)

The number, timing and spacing of the required vaccine doses is set by the Centers for Disease Control and Prevention's (CDC) Advisory Committee on Immunization Practices (ACIP). To be considered valid, a dose of vaccine must meet both the **minimum age and minimum intervals** as defined by ACIP. You can view the current ACIP vaccine schedule for persons 0 - 18 years of age at www.cdc.gov/vaccines/schedules/downloads/child/0-18yrs-child-combined-schedule.pdf. Vaccines are recommended for rotavirus, hepatitis A, influenza, meningococcal disease and human papillomavirus, but are not required.

Colorado schools are required to review immunization records for school entry and can only accept valid doses of vaccine. Your patients may receive notification of noncompliance if a dose of vaccine does not meet the minimum age or minimum interval requirements, per the ACIP schedule. There are three ways a student can meet the compliance requirements established by Colorado law:

- 1) A student is considered fully immunized if he or she has received all doses of school-required vaccines according to the current ACIP schedule. Note: students are required to receive their final doses of DTaP, IPV, MMR and varicella by kindergarten entry and their Tdap by 6th grade entry, even if the student is under 11 years of age.
- 2) A student is in the process of becoming up-to-date on required vaccines and has a written plan from the parent/guardian on file with the school.
- 3) The student's health care provider (medical doctor, doctor of osteopathic medicine, advanced practice nurse or delegated physician assistant) has signed an official *Immunization Medical Exemption Form* because of a condition that precludes the student from receiving vaccine(s), or the student (emancipated or 18 years of age or older) or student's parent/guardian has submitted a signed non-medical exemption (religious or personal belief).

If students do not meet at least one of the compliance criteria, they are not permitted to attend school. If you have questions about the student's school immunization requirement, please communicate with the student's school nurse or school representative.
